



## **2018 EDHS Cougar Band Disneyland Trip!!! Payment and General Information**

Students of the 2017-2018 EDHS Marching/Symphonic Band are invited to participate in an educational and fun field trip to Disneyland at the beginning of Spring Break. Exact dates will be determined by Disneyland but we have requested to perform and have a workshop in the park between March 24 through March 28, 2018 (we are aiming to have one day of travel down, two days in the park, and one day of travel back for a total of FOUR days).

Our current cost estimate is \$350 per student. Adjustments to cost may be made once we have a final head count of participants and actual costs have been solidified. Payments may not be returned in whole or in part after they are submitted. Payments not made by the following due dates will result in the student being dropped from the trip:

**\$50 deposit, with signed student contract - due Friday, November 3, 2017**

\$100 - due Friday, December 1, 2017

\$100 - due Friday, January 12, 2018

\$100 - due Friday, February 2, 2018

*\*You may arrange a different payment plan if you need, please contact Mrs. Sabado to do so. A limited amount of scholarships for this trip are also available.*

Parents interested in chaperoning this trip should contact Mrs. Sabado directly. We have already had a LOT of chaperone interest so not everyone will get to go as a chaperone, however you and any friends or family members you choose may buy discounted tickets to the park for the same dates as the band trip-we will send out more info on that soon. Chaperones must be fingerprinted and cleared by the district in order to attend this overnight trip (\$65 fee for fingerprinting, paid by parent).

STUDENT CONTRACT**

By signing this contract I, \_\_\_\_\_ confirm that I will be traveling under the supervision of the EDHS Music Director and Disneyland Trip Chaperones to Anaheim, California for four TBD days between dates March 24-March 28 and that I will adhere to the following rules and guidelines. I further agree that my failure to live up to this contract can result in my being returned from the trip early **at my own or my parent/guardian's expense.**

1. **Once payments are made, including the payment accompanying this contract, they may not be returned in whole or in part after they are submitted. Payments not made by provided due date(s) will result in being dropped from the trip.**
2. I will follow all directives and particulars concerning this trip set by the EDHS Music Director and Trip Chaperones; including room assignments, bus assignments, itineraries, performances, etc.
3. I will practice and prepare performance literature for performances on my own so as to not detract from the overall success of the ensemble(s) in which I am involved.
4. I will not bring or consume alcoholic beverages.
5. I will not bring or use tobacco products or drugs other than those listed on my health information form.
6. I will not participate in sexual activities.
7. I will not be insubordinate.
8. I understand that room assignments are final and that rooms will be checked periodically. I will not enter a room assigned to the opposite sex.
9. In the event of an emergency, I will immediately contact the EDHS Music Director or trip chaperones.
10. I am required to wear my **Blue** Music shirt or other **Blue** "Blue Crew" shirt that identifies EDHS at all times while on Disneyland property. Dress for the entire trip should be presentable. I understand I will be on view by the public and should represent my class and my school.
11. The Disneyland Trip is a school activity; I understand that although I am not on the EDHS Campus, all school regulations and guidelines are in effect for all students, including those students 18 years of age or older. Students are not permitted to go off on their own or deviate from the planned itinerary. No car or motorbike rentals.
12. As a representative of EDHS, I will represent myself, my school and Placerville, CA in a proper manner at all times. I understand that I am responsible for my own actions and that I will be held solely accountable for those actions.
13. I understand that chaperones have tremendous responsibility while on this trip. They do not wish to be looked upon as police officers, nor do they care to act as police officers. It is not the desire of the administration to curtail in any way the activity of any member of the class to the extent that the trip would not be enjoyable. Complete cooperation will make this trip a pleasant and memorable one for all concerned.
14. I understand that **failure** at any time to follow the regulations for the trip or the authority of the chaperones will **result in my being sent home**. If it becomes necessary for me to be sent home, my parents will be notified and will be directly responsible for all expenses and all transportation costs incurred.
